Pelo presente instrumento particular, **LIBERTY SEGUROS S/A**, sediada à Rua Dr. Geraldo Campos Moreira, 110, Brooklin, São Paulo/SP, inscrita no CNPJ/MF **61.550.141/0001-72**, doravante denominada **SEGURADORA**, representada neste ato por **BGM ACESSORIA DE COBRANÇA LTDA ME**, CNPJ: **07.821.685/0001-86**, e de outro lado, **JOSE RODRIGO DA SILVA** - CPF: 039.701.044-32, E-mail: rodrigoocowboy17@gmail.com, Fone: 85-99194-9265, domiciliado a Rua: Professor José Henrique, 1631, Messejana, CEP: 60840-145, Fortaleza – CE, doravante denominado **ACORDANTE**, mediante as cláusulas e condições seguintes:

Cláusula Primeira - O **ACORDANTE**, em razão do Sinistro nº: **16675376** - ocorrido em 15/02/2024, envolvendo os veículos: Chevrolet Onix de placas SBF-5D75 (segurado), e o veículo Volkswagen Fox de placas OBT-2E17 (acordante) o qual causou danos materiais a Sra. Maria Carmem Lucia Freire e Silva no importe de R\$ 3.400,62, valor este já indenizado pela **SEGURADORA**, resolve por bem transacionar por meio do presente Instrumento.

Em prol da formalização deste acordo e por mera liberalidade, a Seguradora concede uma porcentagem de 41,19% de desconto, que corresponde à R\$ 1.400,62, referente ao prejuízo.

Cláusula Segunda - Por tal razão, o **ACORDANTE**, compromete-se a pagar neste momento, o valor de **R\$ 2.000,00**, em parcela única com vencimento para a data de 18/07/2024, representada por boleto bancário, cujo valor representa 58,81% do montante devido, despendido pela **SEGURADORA**.


Cláusula Terceira - Fica expressamente convencionado que, nos casos de pagamento em cheque a quitação se dará após sua compensação na rede bancária.


Cláusula Quarta – Não havendo pagamento pelo **ACORDANTE** conforme ajustado na **Cláusula Segunda**, este será constituído em mora, tornando-se exigível todo o saldo devedor do acordo de uma única vez, sobre o qual incidirá, correção monetária, juros de mora de 1% ao mês e multa moratória de 2%, bem como, despesas de cobrança, processuais e de honorários advocatícios a razão de 10% sobre a totalidade do valor devido, estando ciente ainda o Devedor que poderá ter seu nome inscrito nos Serviços de Proteção ao Crédito.

A Seguradora, na ocasião de eventual inadimplemento do acordo, cancelará qualquer desconto concedido, acima, retomando os procedimentos de cobrança do valor integral do sinistro sofrido, sem prejuízo da cobrança de despesas administrativas, processuais e de honorários advocatícios.

Cláusula Quinta – As partes concordam que esse instrumento particular de transação servirá como título executivo extrajudicial em caso de descumprimento de quaisquer das cláusulas mencionadas.

Cláusula Sexta – Este acordo não inclui os valores pagos pelo segurado a título de franquia.

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, GARCIA SERVICOS DE COBRANCA LTDA (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Getting paper copies

Unless you tell us otherwise in accordance with the procedures described herein, we will provide electronically to you through the DocuSign system all required notices, disclosures, authorizations, acknowledgements, and other documents that are required to be provided or made available to you during the course of our relationship with you. To reduce the chance of you inadvertently not receiving any notice or disclosure, we prefer to provide all of the required notices and disclosures to you by the same method and to the same address that you have given us. If you do not agree with this process, please let us know as described below.
